



Patriot Side Pot Information Summary



\$100 Patriot membership is required to enter side pots and advance to semifinals.
(Must purchase on patriotevent.com)

Hooley Jr Patriot Year 2024-2025 is offering a dual qualification for each approved qualifier throughout the season. The dual qualification is for Las Vegas, NV, in December of 2024 and Ft. Worth, TX, in March of 2025.

Side Pot Fees:

Ft. Worth side pot fees for 19U events are \$200.

Las Vegas side pot fees for 19U events are \$100.

For a Dual qualification, 19U side pot fees are \$300

The maximum qualifications per discipline are 2 times.

Ft. Worth side pot fees for 15U and 12U events are \$150.

Las Vegas side pot fees for 15U and 12U events are \$75.

For a Dual qualification in the 15U and 12U, side pot fees are \$225.

The maximum qualifications for both age groups per discipline are 2 times.

Number of qualifications awarded have changed and are based on how many contestants are entered in the event/discipline Patriot side pot. This will apply for all age groups. If 19 or less contestants are entered in the age group event/discipline Patriot side pot, 5 qualifications will be awarded for that event/discipline. If 20 or more contestants are entered in the age group event/discipline Patriot side pot, 10 qualifications will be awarded.

The Las Vegas Finals will be the same format as the Ft. Worth Finals with a Last Chance Qualifier, Semi Finals and Final performance at 10:00AM December 14th at the Plaza Hotel & Casino Downtown Las Vegas.

Chris Neal's Las Vegas Stars, held at the Plaza, will host the Last Chance Qualifiers and Semi Finals for all Tie-Down and Breakaway events.

Patriot Vegas will host the Last Chance Qualifiers and Semi Finals for Barrels, Poles, Goat Tying, Steer Wrestling and Team Roping. All events Last Chance Qualifiers and Semi Finals will be held at the Plaza Hotel & Casino except the Team Roping Last Chance Qualifier will be held at Horseman's Park.

Patriot Vegas will advance top 10 straight across all events/disciplines and all age divisions from the semi finals to Vegas final performance.

Ft. Worth Finals will have a similar format as March of 2024 with Last Chance Qualifier, Semi Finals and Final performance for all age events/discipline groups.

Top 15 will advance in 19U age divisions to Ft. Worth Finals Performance with a \$100,000 bonus round.

Top 10 will advance in 15U and 12U age divisions. 15U and 12U will have its own performance on Saturday night and will have a \$50,000 bonus round.

Patriot has implemented a point system for all qualifiers. The points for each contestant's event/division will accumulate for the top 15-point earners of the year and will be eligible to enter an added money event at the finals in Ft. Worth as well as prizes.

Points will be awarded to the top 10 of every event at each qualifier regardless how many qualifications are awarded. After a contestant has their 2 qualified spots for Ft. Worth and/or Las Vegas, they can continue entering side pots for points only. The contestant with the most accumulated year-end points across all events will be awarded a prize bonus.

The points system will be as follows:

There will be “super qualifier” events for contestants to earn double points. Super qualifiers will award points from 20 down to 1 for points. The points system will be as follows:

Open and 10.5 team ropers will earn qualifications to Ft. Worth semifinals and Las Vegas semifinals by entering the Patriot side pots for qualifying events. Teams must be entered in a 19U team roping event and side pot to qualify for the 19U Open and 10.5 team roping. A team roper can only qualify 2 times total in each Open and 10.5 division. For Example: 2 heading, 2 heeling, or 1 heading and 1 heeling. Team ropers will be allowed to switch ends to meet their 2 total times to qualify. A roper can choose his/her partner for Ft. Worth semifinals and Las Vegas semifinals only if the partner has entered a qualifying Patriot side pot. If a partner is chosen and hasn't earned a qualification position, the fee for the chosen partner is \$750.00.
