

Patriot Events/Jr Patriot Rodeo - Full and Unconditional Release for Participation 2023

PARTICIPANTS and THEIR PARENT and/or GUARDIAN if under age of 18, as well as any HORSE OWNER lending or renting a horse to a Participant HAVE READ AND VOLUNTARILY AGREE TO THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT on this form and further agrees that no oral representations, statements or inducements apart from the foregoing written agreement have been made. The Patriot Event, LLC has the right to refuse entry to anyone for any reason it deems necessary. Each participant in The Patriot Event is fully aware, completely understands, and accepts that participation in the Event, whether as a contestant, independent contractor, employee, volunteer, exhibitor, sponsor or spectator, is dangerous and that the events and activities associated with, relating to, arising out of, and concerning this participation present substantial, serious, and real risks of personal injury or death to the participant, and the loss of, damage to, or destruction of the participant's personal property including livestock.

In Consideration of being permitted to participate in, enter upon and use the Will Roger's Memorial Center, all its' parent and affiliated entities, and associated facilities for The Patriot Event, Jr Patriot Rodeo, and/or Event Qualifiers, the participant for himself/herself and all persons under his/her management and control including minor children, does acknowledge the dangers inherent in horse related events, and in the use of the facilities, fully and completely accepts and assumes these substantial, serious, and real risks whether or not apparent, known, unknown, foreseen, unforeseen, present, or contingent, and whether or not caused by any negligence of the Released Parties, or the negligence of any contestant, volunteer or spectator including but not limited to, any negligence associated with the design or designing, staging, supervising, maintaining or in any way presenting, conducting or sponsoring The Patriot Event, further does agree to use extraordinary care and prudence in his/her activities and those of charges, and does: **HEREBY RELEASE, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE** the organizers or any subdivision thereof, chairmen, agents, officials, and does;

All contestants, parents and/or guardian understand that The Jr Patriot Rodeo is owned solely by Patriot Events, LLC and all finale events will commence and conclude at Will Rogers Memorial Center in Fort Worth, TX.

STALLING: Contestant, parent and/or guardian, sponsor, and/or horse owner stalling on the Will Roger's Memorial Center grounds understand and assume full responsibility for the health and safety of themselves and the animal(s) in their rented stall. Further, they understand that only one horse per stall is permitted, and no subletting or nightly rentals is allowed. If horse is without rented stall and is not entered in an event on grounds, trespassing charges could apply. No tie outs or portable pens allowed.

CANCELATION/REFUNDS:

Contestant is responsible for following refund deadline policy. Fort Worth Patriot Deadline is Feb.1. Shall Event be Canceled by producer for any unforeseen matter, all remaining fees paid to Patriot Event and/or Jr Patriot Rodeo, including entry and stall fees will be returned within 15 days of event cancelation. Processing fees are non-refundable. Yearly membership dues are non-refundable. Disqualified contestants forfeit all fees and possible membership (see complete rules for details).

The participant also agrees that upon entry to any event at The Patriot Finale, Jr Patriot Rodeo, or its qualifying events, he or she has read and understands said agreement whether the signature has been returned or not.
