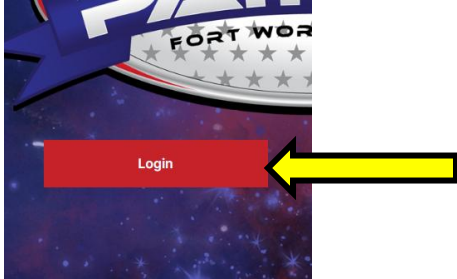


Instructions How to Enter Rough Stock for Hooley Jr. Patriot Finals

Email should include: full name, date of birth, city and state

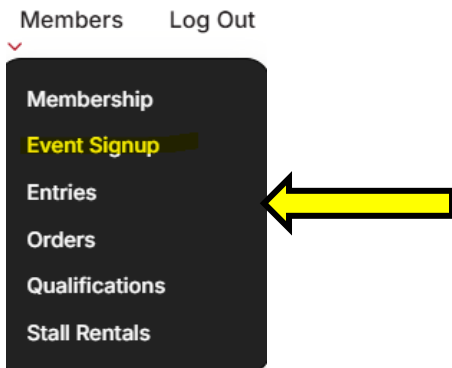

- Click the division and option for the division to enter **(If needing to enter Bull Riding and Mutton Bustin, click Bull Riding and Mutton Bustin)**

**Be sure and pay attention to the options. Each event and each day have 2 options.
First-Make a decision what day or days to enter**

Options for each day- Can only enter one or the other (only one time per day)

OPTION 1- FEES INCLUDE SIDE POT- this is the fees to enter the event plus the side pot fees to be eligible to earn a qualification for 2026 Fort Worth Finals

OPTION 2 – NO SIDE POT FEE -This is only the \$200 fee to enter the event.

CONTESTANT WILL NOT BE IN THE SIDE POT TO BE ELGIBLE TO QUALIFY FOR THE 2025 FINALS

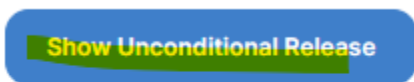


- Click the “I agree box”


Double check your “Cart” once again to make sure the entries are correct. If all the disciplines are not there go back and add them or uncheck the box next to the incorrect purchase.
